Objectives

- 1. Create awareness about the building conservation concept in all sectors of society
- 2. Create public awareness on the benefits of building conservation practices (energy, water)
- 3. Mobilize People And Encourage Them To Embrace Energy Conservation Strategies
- 4. Motivate consumers to adopt building conservation practices in the local construction market

Technical Criteria

Buildings shall be evaluated based on specific criteria developed by a team of experts, as follows: HVAC SYSTEM • LIGHTING • PLUMBING FIXTURES • LANDSCAPE • OPERATION AND MAINTENANCE PRACTICES • BUILDING ENERGY MANAGEMENT, BUILDING AUTOMATION • SUSTAINABILITY MEASURES • SPECIFIC ENERGY/WATER CONSUMPTION • BUILDING ENVELOPE

Application

You can apply to the competition if your building falls under one of the following six sectors:





All applications shall be submitted through TARSHEED's page on KAHRAMAA's website (www.km.com.qa/tarsheed), where the competition Terms and Conditions are available. Only existing and operational buildings are eligible to participate in the competition

Buildings excluded from the competition:

- 1. Buildings with conventional window air conditioners
- 2. Buildings having landscapes with flood irrigation systems
- 3. Applicants evaluated and awarded in earlier years

Buildings shall be evaluated in several phases by a panel of experts, etc. The minimum qualifying grade decided by KAHRAMAA is required for considering the building for an award in all categories except residential.

Winning buildings from each sector, shall receive an award and a certificate for being a role model in the field of Building Conservation and shall be honored during the 6th Tarsheed Annual Celebration on April 22nd, 2018.

General conditions:

The QID, mobile number and landline number of the individual applicant who will be representing any firm/building is essential in the application.

For residential applications, the building shall be owned or leased by the applicant as per KAHRAMAA records.

If any third party or consultant is applying on behalf of any installation, he shall provide a formal authorization letter from the parent company/firm with contact information and the same shall be uploaded along with the application.

KAHRAMAA will conduct site inspections and will be required to take photos/videos of the facility for any energy saving measures as needed.

The applicant shall be responsible for obtaining any permissions in a reasonable time for general entry into the premises, security passes, permission for photography or videography and transport within the facility.

Built up area of the building and KAHRAMAA electricity number as per the application requirement shall be provided by the applicant.
